Statement of Accounting Policies

Oratia District Ratepayers' and Residents' Assn (Inc)is an incorporated society registered under the Incorporated Societies Act 1908 with the Incorporated Societies Office. Reliance has been placed on the fact that the Entity is a going concern. Accrual accounting is used to match expenses and revenue where practical

Basis of Preparation

These financial statements have been prepared in accordance with the Special Purpose Framework for use by Not-For-Profit Entities (SPFR for FPEs).

Historical Cost

These financial statements have been prepared on a historical cost basis. The financial statements are presented in New Zealand dollars (NZ\$) and all values are rounded to the nearest NZ\$, except when otherwise indicated.

Changes in Accounting Policies

There have been no changes in accounting policies. Accounting policies have been applied on a consisent basis throughout the reporting period.

Income Tax

The Entity is exempt from Income Tax.

Goods and Services Tax

The entity is not registered for GST. Therefore all amounts are stated inclusive of GST.
